Eighth Amendment Excessive Fines clause prohibits disproportionate forfeitures of property. In *Waters-Pierce Oil Co. v. Texas, 212 U.S. 86 (1909)*, the Supreme Court held that excessive fines are those which are "so grossly excessive as to amount to a deprivation of property without due process of law." A true and correct copy of the unauthorized use of private conveyance demand letter is incorporated herein as reference (*EXHIBIT "A"*) Nassor Mooruts Bey shows the court the following:

Owner, Nassor Mooruts Bey is entitled to lawful possession of the seized property;
