COMES HERE NOW, Nassor Mooruts Bey ex. relatione, VICTOR LEON WASHINGTON and state and Publish for the Record: My 'Declaration of Status': Aboriginal / Indigenous Natural Beings; Freehold by Birthright, Inheritance and Primogeniture; Affirming my Substantive Rights to Travel upon the public Roadways and Highways, in harmony with the Highest and most supreme Law of the Land. Universally declaring I Am progeny of the Supreme Being - Creator of everything seen and unseen. I Am 'In Propria Persona' (Not Pro Se); and not 'Cognate' to any 'Nom de Guerre' – not negro, black, colored, african american, 14<sup>th</sup> amendment artificial citizen of the U.S. or a citizen or member of the union states, or any other such like fiction entities; created by the hands of others by way of Misrecital or 'Artificial Legal Construct'; NOT A SOVEREIGN CITIZEN misnomer, nor a 'Man-of-Straw'; as written, typed,

5. The full untampered dash-camera video;
6. Information of what legal duty performance was being opposed.

§ 322.212(1)(a):

1. The date of the offense;
2. The place of the offense;
3. The circumstances observed constituting the offense;
4. The time of the offense.
5. The information that makes the Natural Person’s Moorish American Nationality and Identification Card unlawful;
6. The names of people intended to be defrauded by the Natural Person’s Moorish American Nationality and Identification Card.

**WHEREFORE**, pursuant to Fla. Stat. 3.140(n) for information; this court is demanded to enter an order for requested relief.
